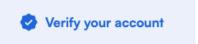


Director Verification

As part of your listing on ILOCX, we are required to verify the ID of each Company Director. There are two methods to verify your ID, the simplest is by using our online identification verification system.

Manual Verification

Alternatively, you can attach the following documents with this declaration:

Certified proof of identity

This must be certified as a true copy by someone authorised to certify documents, and can include a Passport, Photo Drivers License or National Identity Card.

Certified proof of address

The document must be dated within the last 3 months, and must show both the name and address

A letter of reference from a bank

This should be made out to ILOCX Limited, and requires no financial information, only that the Director has an account in good standing.
